Terms and conditions of Application - "Farmers Awards"

These are the terms and conditions of application, including information on how to participate in the Farmers Awards.

8. If the award remains unclaimed for 6 months, another award winner will be picked from the remaining eligible applicants.
9. If requested by the sponsors, the Farmers Award winner must produce, within the time requested by the Sponsor at its absolute discretion, appropriate photo identification or other documentation, required by the Sponsor to verify their identity, age, eligibility to enter the Farmers Award and compliance with these terms.
10. The Farmers Award will only be awarded following all validation and verification requirements of the sponsor being met to its satisfaction.
11. Eligible applicants will enter the Farmers Award only once.
